Summary of Findings: As reported in the 2016-2017 employer satisfaction

survey, our graduates have demonstrated improvement in the areas of being qualified and competent. On a five point scale, the mean showed that in the area of being qualified, the score was 4.05 (compared to 3.56 in 2010). In the area of being competent, the score is 4.11 (compared to 3.62 in 2010). In other words, more than 75% of the school administrators are satisfied with the qualifications of

our graduates.

#### **Overall Recommendations**

A critical area we need to keep working on is preparing our students to successfully develop and pass the edTPA. This requires quite a bit of mentoring and support, especially during their student teaching assignments. Nine submitted their portfolios. Of those, eight passed. This is one of the requirements for the NYS initial certification.

Another area that the program needs to address is increasing the number of students who pursue a secondary-level certification, especially in the area of science and math. There is a demand for teachers in those areas. The program has the resources to prepare prospective science and math teachers. The issue is recruiting them.

Although there has been much improvement in this area, the ASL skills among some of our students need to be addressed. There is always one or two students who struggle to improve their receptive and expressive skills. This has an impact on where they can do their student teaching assignments.

#### **Overall Reflection**

The director and faculty strongly believe that we had a very successful year. The pass rate for the certification tests has been better than 80%. All of our recent graduates have applied to receive their NYS certifications; four have received them, the other seven are in process. Of the 11 graduates, nine are currently teaching in various school programs. We feel that the program has made great stride in preparing our students to become teachers.
