## **Comments:**

(Summary/Reflections on progress made since AY 2006-2007 Middle States Report)

## Summary of Work so far:

AY 2006 was the first year after the BS degree underwent a major curriculum change. In 2006 and 2007 some of the data report in the outcomes assessment reflects students going through the old curriculum, however, we can still see progress being made.

Outcome assessment items #1, #2 & #3 look at an aspect of the students' skill in ASL and in interpretation. In all three items the results mostly surpass the goal stated in the assessment of outcome.

In item #4 the results have surpassed the employment goal of 95%.

Items #5 & #6 requires the use of the NTID Alumni Satisfaction Survey. This survey does not collect the data we need to sufficiently answer alumni satisfaction. WE are in the process of developing another instrument.

Item #7 addresses student satisfaction. We only have data from 2007 which shows approximately 68% satisfaction; the goal is 80%. This year will give us a second measure of a larger class.

**What have we learned:** We are collecting and reporting data in a more systematic way. It is clear that we need several more years of data to draw any major conclusions. However, the little data we have is affirming.

What impact on curriculum and instruction: No curriculum changes will occur until we have several more years of data.

**Recommendations on Actions:** We have seen that some of our instruments are giving us the data we need while others are not. We have taken steps to improve this.
