Findings for 2a. Final Grade Report for Freshman Seminar Course

Summary of Findings: 83% of students taking Freshman Seminar earned A's, B's and C's from Fall 2014.

Results: Acceptable Benchmark Achievement: Not Met

Recommendations: None - students who did not do well will need to repeat Freshman Seminar.

Reflections/Notes: Students who do not do well may not be ready to stay and may have earned poor grades in their other classes.
