Academic Transcripts

If you are applying for admission to college for the first time, you should request that your high school guidance office submit an official copy of your secondary school transcript to RIT's Undergraduate Admissions Office.

If you have previously attended college, you should request immediate forwarding of official college transcripts from all colleges previously attended. If you have completed fewer than 30 semester hours or 45 quarter hours, you must also submit official secondary school transcripts in addition to college transcripts.
