- RIT Education Abroad Travel Grants provide funding for RIT students to study abroad - from \$500 to \$2,500. Ask a study abroad advisor for more details.
- Honors students are eligible for a \$500 travel grant to study abroad.



### When You Should Go:

The optimal time for Saunders students to study abroad is during their 2nd or 3rd year.
