

Helping New York State Schools Buy More Green Products

The Healthy School Network (HS Network), founded in Albany, NY in 1995 strives to ensure every child has an environmentally healthy school. Recognizing kids' special vulnerabilities, HS Network has an emphasis on preventing exposures to harmful chemicals in schools by pressing for a range of pollution prevention measures. These measures include nontoxic supplies, green cleaning, safer pest control, and reduced, targeted disinfectant use. HS Network also pursues child sensitive standards for school siting, design, construction, new environmental public health services and interventions for children with suspected exposures in schools.

Challenge

With a state law in place, along with good experience using green cleaning products, New York State P-12 schools and districts still find themselves behind state agencies when it comes to purchasing other types of green products. HS Network's Buy More Green Products project aimed to inform school elected and appointed leaders, custodians, teachers, and parents of New York State's highly effective green procurement initiative and provide helpful workshops and webinars on how to find and use greener products in schools and at home.

Solution

HS Network's educational project continued to collaborate with several major school constituency groups such as the New York State Parent Teachers Association (NYS PTA), New York State School Facilities Association (NYS SFA) and New York State United Teachers (NYSUT) to raise awareness and promote behavioral changes. HS Network developed a presentation and handouts about acquiring greener products that reached 40 individuals (via webinar and in-person). Additionally, HS Network advised the New York State Association of School Business Officials (NYS ASBO) via an educational green cleaning policy paper and presented to the New York State Council of School Superintendents at its annual Leadership Conference in the fall. Educational flyers were also developed and use as tools to support this program.
