

Subject: Decision of the Approving Committee for Student Exchange for Erasmus +

The Approving Committee for Erasmus + mobility (Committee in further text), after the completion of the processes as designated in the Call for Applications for Traineeships subsequent to the Agreement 2021-1-HR01-KA131-HED-000007625 and 2022-HR01-KA131-HED-000055197, published on the webpages of RIT Croatia on March 1, 2023, at the meeting of May 5, 2023 made the following

DECISION

1.

Ten (10) student applications in total have been received for Erasmus + program Key activity 1 – Mobility for Student Traineeship.
