

## PAYMENT PLAN REQUEST 2023/2024

As of 2009/2010, RIT Croatia offers its students a payment plan option in order to assist with timely payment of tuition dues. This payment plan splits the semester tuition dues into five equal installments. The advantage of the payment plan is that you will be able to more easily manage your tuition dues.

### Payment Plan Terms and Conditions

1. Full time student status is 12-17 credit hrs for each semester.
2. In case of registration of less than 12 credit hrs, or more than 17 credit hrs, the tuition total payment will vary according to the terms and conditions as outlined in the Student and Parent Handbook.
3. The 5 installment due dates and amounts for each semester are as follows:
