Dear Internationally Passionate Colleagues,

We are very excited that you are interested in leading a faculty-led study abroad program. Each year, faculty-led programs support the mobility of 250+ students, about half of RIT's total annual study abroad participation. Developing a program and leading a group of students overseas is a complex process that takes a year of planning and engages multiple campus partners, including Risk Management, Office of Legal Affairs, Registrar's, Student Financial Services, Financial Aid, Access Services, and more. We greatly appreciate your hard work and fortitude in organizing such impactful experiences for RIT students.

Each year on January 1, we open the call for proposals for new faculty-led programs for the following academic year. Our website is an excellent resource for guiding you through the process of faculty-led program development: https://www.rit.edu/global/lead-a-study-abroad-program. Before you submit a Phase 1 form, it is highly recommended that you meet with the Program Manager in the Education Abroad office to discuss your program ideas. Please complete all fields in the form below, gather appropriate signatures, and submit to the Education Abroad office by emailing it to faculty-led@rit.edu by the deadline on March 15.

RIT has the capacity to support about 20-25 total faculty-led programs each year. This way, we can ensure each program has the support and attention it needs to be safe and successful. Unfortunately, that means not every proposed program will be accepted. Program selection is a strategic process that evaluates proposals and selects programs that:

- Do not compete with each other or our global campuses and therefore dilute participation.
- Cater to a sufficient student audience that makes the program viable.
- Meet strategic goals around location preference, student audiences engaged, and partners utilized.
- Maximize college and department resources by being repeatable 2-3 times over the course of 5-6 years.
- Have reasonable and feasible costs for students as well as the colleges/departments that might be contributing funding.
- Engage new faculty and give others a chance to lead a program.
- Meet RIT's basic health and safety requirements (No high-risk activities, U.S. State Dept. Travel Warnings).
- If it is a renewed program, demonstrate the success of previous iterations.

We appreciate your understanding as we work to create a suite of programs that maximize student interest, existing resources, and faculty engagement. If your proposed program is not selected to run this year, we are very happy to discuss other ways to support your internationalization efforts.

- Attend a mandatory Pre-Departure program
- Cannot have had a conduct violation on a previous study abroad experience that resulted in a probation or removal from program
