Artificial Intelligence Taskforce

Chris Collison, Director of Al Hub and Initiatives

Al is here to stay:

- Jobs becoming obsolete 1880's lighting street lamps to 2024 where they automatically turn on.
 - Typewriters turned photocopiers.
- Al is transforming how we work
 - It automates routines tasks, frees time for higher level work
- Legal, Complaint & Ethical Use:
 - A call to personal principles
 - Augmented Learning
 - Adobe Express Premium Licensed Images
 - Sustainable use Carbon neutrality
- What is Al?
 - It started with Machine Learning linear regression
 - Now using features and labels
 - Deep Learning -> Neural networks, computer vision
 - o Transformers, large language models
- Agentic AI:
 - o Central LLM Brain
 - Reasoning
 - Planning
- Al Hub Goals
 - Al in Education:
 - Long Term: Learning Al
 - Al Guarantee: All students get an Al experience
 - Al for non-majors
 - Social/Ethical Impact

 - Learning AI while Teaching AI:

- In Closing:
 - o Al is an enabler:
 - Al amplifies human abilities rather than replacing them.
- Questions:
 - How do you plan to protect personal/individual creativity?
 - How do we choose to share it? There are guidelines to protect personal

creativity already (uploading a copyrighted song on youtube). There is a switch to turn on not allowing AI to train using your input. There are ways to protect various things. Be mindful of how we upload/share. AI gives us the opportunity to be more mindful about how we're using/sharing information.

- What is RIT's step on introducing a policy on AI? Each college has different needs and if they look those needs up, are they actually learning anything?
 - I use AI, but I'm not pretending I was not using it. In the focus groups, some faculty say not to use it at all and some say yes but with restrictions. There are a lot of conversations happening right now to decide that policy.
- o If you use AI to train AI, how are you not going to garbage in, garbage out?
 - You have to play with it. If you ask for it to write an essay without giving ANY information, you're going to get garbage. But if you give it information you have already gathered and ask AI how to organize it / what you need to be doing with a template, etc.. that is how you won't get garbage.
- In a learning environment, how do you encourage people to actually look at the information they're getting instead of just the answer?
 - If a student uses AI to write an essay and get an A while another doesn't and gets a B, it's not fair. In class, if I'm going too quickly for a student to keep up, they can use AI to fill in the gaps. If I really want to learn it, I'm going to read the paragraph given / watch the youtube video.
