PRESENTATIONS

RIT Parking and Transportation

John Connely, Director of Parking and Transportation, & Joel Mazeika, Transportation Manager

- Everyone's favorite subject!
- I've worked with all the contractors to get workers out of our parking lots into more remote lots to then be transported to their site.
 - Moving forward, we are reverbing contracts where this language will be included where workers will NOT be allowed to park on campus lots.
- R-Lot is coming back up next semester!
 - This will help take ~61 cars out of S-lot. We will then push up the reserve parking up one to add an extra row of general.
- Wherever I can find spots, I will try my best to add them.
- When the university is open, but no classes, parking will still be enforced.
- Questions:
 - o CET: How many spots without B lot?
 - 9500 spaces on campus, B lot is 900 spaces.
 - Ops: How lenient will you guys be on parking when the shuttles do not run at all last minute?
 - Park Mobile in G&H-Lot all day for \$6. \$1.50/per hour for closer spots
 - SA: You mentioned parking with large events, have you thought about making a larger lot for them and enforcing them to park there? I think it's unfair to allow them to park on campus when students should be the main priority?
 - Any events larger than 40/people must go to B-Lot. When we have a lot of events on campus at once, we have to be careful. We aren't building any parking structures, the ROI is not worth it anymore.
 - Student: When career fair is in D-lot, we are missing a lot of accessible spaces for our students, how are we going to fix this?
 - We have discussions with the event holders. In large events like graduation, we make sure we have D & U lot as only
 - o SCB: New lot for Gene Pollissini?
 - That lot used to be 3 times the size before the rink was there. We commissioned a study for that area because it's wetlands. In order to develop 110 spaces, we'd have to spend several million dollars.
 - SA: Have you considered making a no-tolerance policy for B-lot parking for large events?
 - Dr. Watters wants events to generate revenue. With reasonable accommodations for events, we have 9500 spots on campus. If it's in prime-time parking, we'll say no. To put every event in B-lot just isn't very reasonable. We have the plan for our new transportation contract, but that won't be enacted until September of next year.
 - CHST: For the tickets there are some leniency, but what do you say to those who give out the tickets?
 - For whatever reason if we have 4 missing shuttles, we'll tell the team just not to enforce the parking in G & H-Lot. We have to keep in mind the true commuters that come to campus. If we allow people living right off campus to drive, it takes away from those commuters.

- President: Is there any way to develop a way to show students the capacity of a lot?
 - That technology is really expensive (the cameras and getting the power there) and there are a LOT of entrances and exits to each lot.
- COS: Is there any way to show the park mobile spots better?
 - G,H&L lots are daily decision lots and the park mobile is for the entire lot, but it is also general parking.

Transportation:

- We're looking for a new 10 year transportation contract, as ours ends in August.
- RIT shuttles are free for any member of the RIT community. There are no ID requirements to board the shuttle. If a driver asks you, please alert me because they shouldn't.
- Passio Go app is for tracking. The new UB shuttles are not equipped with our tracking.
- "On-Campus"
 - ~7AM 1AM, 7 Days a week.
 - Service provided around campus
- o "Off-Campus"
 - Connects with RTS on weekdays
- o RIT Van Rentals
 - Student groups must submit rental requests through EMS, no later than 14 days BEFORE your event
 - All drivers must be certified
 - Any trip exceeding more than 250 must have a minimum of 2 certified drivers
 - No driver may operate a van for more than 4 hours per day
 - The maximum travel time from RIT to destination must not exceed 8 hours.
 - Parking and Transportation Servers reserves the right to cancel a rental without notice
 - Weather related issues.
 - Mechanical issues cars aren't safe for the road.
- Student Driver Certifications
 - Student drivers certification are valid for 1 year from the issuance date
 - Students with licenses
- Ouestions?:
 - ACA: Is there a fee for certification?
 - \$25 fee, if it's for a club, it can be covered by the budget. If you don't know where to start, go to campus life
 - SCB: Do you have stats on the Van?
 - Yes, we have a current fleet of 8, next weekend all 8 of them are booked out. They're used VERY frequently
 - Student: Are driver breaks / loading & unloading times built into the schedule?
 - Yes they are!
 - SCB: I'm glad you guys reopened the Saunder's Loop.
 - That was always the plan once Saunders revamp and SHED construction was done!
 - COS: Is there a reason why the schedules aren't on the Passio Go app?
 - That sounds like a Passio Go issue, but I will check it out and report back to the FPaT Committee with the answer.
 - Student: I see near collisions around G&H-Lot between shuttles.

Please report it in. RIT service center is the best way. This gives me a
document trail. There are cameras on the shuttle so we can review it!
If it's just a car, get a plate or partial plate.
