Advisor Superpowers

- Student Government is an advocacy group and within the campus governance group, this means you have a more impactful role.
- Advisors ensure that you receive stipends, access to accounts and other administrative work. They can also provide guidance to solve issues within the university if you feel stuck.
- Advisors have to balance their support roles as well as their day jobs, they will support you in making changes but will also remind you to follow bylaws and guidelines to ensure changes stay.
- When you are in your Student Government role, you must put your personal politics aside.
- You are students first, please communicate if you are struggling with either your cabinet member or either advisor. It's better to take 3 days away than miss 3 weeks.

Previous Bylaw Changes Overview - Ana Paolini Carrano

- Changes were made by the previous administration, this is an overview of those changes
 - Article 1 Section 3
 - Highlights the changes to RSO's.
 - o Article 1 Section 6
 - Allows the senate the ability to create ad-hoc committees for issues that arise on campus.
 - Article 1 Section 10 Student petitions
 - PawPrints need to be charged within 2 senates.
 - Article 7 Bylaw and appendices
 - Section 1 Lists out the process to amend a bylaw or process by an Student

- Gov. Member or Student.
- Section 2 Provides guidance on how the Dir. of Collaboration and Inclusion should handle policy changes with Dir. of Tech Services
- Section 3 Allows senate to suspend bylaws during 'New Business Section'.
 Ex: Allows the Senate to suspend normal procedure for a set period.
- List of appendices change highlights
 - Appendix A: Added 'Greek Leadership Committee', Added Associate Director of Campus Life Finance to Finance Award process, Added RSO's Finance Committee pitch to Recognized Student Clubs.
 - Appendix D: Gives new RSOs' until April to propose a budget and goal, Changes Budget Committee membership (Adds SG Dir. of Finance and 1 Center for Campus Life Member) and Budget Appeals Committee (5 Senator, 1 CCL).
 - Appendix G: Standardizes Marketing for SG and RSO having their own guidelines.
 - Appendix I: Created to record all bylaw and appendix changes.
 - Appendix J: Process to ensure Student Gov. members achieve goals and fulfill role responsibilities

New PawPrints Procedure - Ana Paolini Carrano

- Pawprints was introduced in 2014, allows students to share issues they'd like addressed by Student Government once they reach 200 signatures.
- Our new process will have the DSR charge PawPrints to committee chairs and open discussion on the motion to charge. After a vote confirms the charge, a discussion will open on the actual pawprint to provide direction for the committee chair, the committee chair will then take a week to explore. The committee will then share a plan to the senate for discussion. Committee Chairs will then only provide internal updates to the senate if there is a major change from the initial plan to ensure the senate is kept in loop. External updates that will be provided externally will also be shared with the senate through Committee Chair Reports. Finally once the pawprint is ready to be responded to the senate will vote to close the pawprint.
- Question:
 - GCCIS: Can anyone provide plans to committee chairs?
 - VP: Yes, during discussion you can provide feedback on the plan
- Ouestion
 - OUTSpoken: Does DSR assign the PawPrints or do we discuss where it goes?
 - VP: DSR motions to charge a PawPrint but as Senate we can have discussion on where it should be assigned before we move to a vote.
